8. <搶人才> 先入住・後付款計劃優惠

Compete For Talents Early Move-in Benefit

(此安排只適用於選擇付款計劃 (D1) 之買方。)

(This arrangement is only applicable to Purchasers who choose Payment Plan (D1).)

- (1) 在買方滿足以下先決條件的前提下，買方可以與賣方簽訂許可協議，在住宅物業買賣交易完成前以被許可人身份入住所購住宅物業：

Subject to the conditions precedents below being satisfied by the Purchaser, the Purchaser may enter into a licence agreement with the Vendor to occupy the residential property purchased as licensee prior to the completion of sale and purchase:

- i. 買方須於簽署臨時合約 5 個工作日內簽署該物業的正式買賣合約；

The Purchaser shall execute the formal agreement for sale and purchase of the residential property within 5 working days from the date of the PASP;

The Purchaser shall, within 90 days after the date of signing of the PASP, sign the licence agreement in the form prescribed by the Vendor's Solicitors (without amendment) in respect of the residential property purchased, the main terms and conditions of which include the followings:

During the licence period, the Purchaser shall be responsible for management fees, Government rent and rates of the residential property concerned. The Purchaser shall also bear all the legal costs and

expenses (including adjudication fee and stamp duty (if any) arising from the Licence Agreement), utilities charges, utilities deposits and all other outgoings, etc. of the residential property concerned during the licence period.
